Registration Fee (Non-Refundable):

Early Registration: **\$460** (until May 15, 2026)
Regular Registration: **\$490** (until July 15, 2026)
Late Registration: **\$520** (after July 15, 2026)

Instructional Fee:

Option 1: 845.00 due before 1st day of school
Option 2: Quarterly payments of **\$211.25** due on or before first day of every quarter as noted on school calendar.

Select Tuition Payment Option:

- Option 1: Annual Payment** (Receive a 2% Discount off the tuition fee):
Tuition payment is due on or before first day of school.
- Option 2: Quarterly Payments** (1% Discount off of the tuition fee):
Tuition installment payments are due on or before first day of every quarter as noted on school calendar.
- Option 3: Ten Monthly Installment Payments: \$495**
Tuition is paid over 10 monthly payments (Aug – May) and is due on the 5th of every month (late fee imposed if payment received after the 10th of the month).

*** All tuition and fee payments for SY 2026-2027 will incur a Convenience or PayPal fee if made with a credit/debit card. To avoid such charges, make payments by check or cash.**

Financial Aid/Assistance – Applications are due on or before **June 15, 2026.**

- Aid is available on the basis of demonstrated need.
- All aid is provided on an annual basis. Applicants need to apply annually. Students receiving aid must maintain a cumulative 77%+ academic rating and satisfactory or better citizenship record. Student must participate in one Club or Sport.
- Applications for financial aid are available to parents when student is registered. The school is committed to assisting qualified applicants. If student does not meet academic criteria, the student will be put on probation for a quarter. If progress is not made, student will lose the financial assistance.
- Financial aid applications will not be processed until all supporting documents are completed and submitted to the Business Office by the deadline.
- Applicants will be informed of award on or before **July 15, 2026.**
- Qualified applicants will sign Promissory Notes on scheduled dates.

Scholarships

The school offers scholarships to support students. For more information, please inquire directly with the Business Office.

Tuition Discounts

- Families with **two (2) enrolled children** will receive a **13% tuition discount**, *unless* one or both children are receiving a scholarship.
- Families with **three (3) or more enrolled children** will receive a **15% tuition discount**, *unless* one or more children are receiving a scholarship.
- If a child is on scholarship, that child **will not** receive the family discount; however, siblings not on scholarship will still receive the applicable discount.
